TERMS AND CONDITIONS GOVERNING FIXED DEPOSIT SCHEME

Applications

- 1) Application should be made in the prescribed form duly completed in all respects and must be accompanied by an 'Account Payee' cheque/draft in favour of **BIRLA COTSYN (INDIA) LTD. - FIXED DEPOSIT ACCOUNT**. Cash will not be accepted.
- 2) The Application Form along with the necessary remittances should be sent to the Managers to the Fixed deposit Schemes, at any of their offices.
- 3) Fixed Deposit will be accepted from resident individuals, Domestic Company, group of persons, registered societies, registered trusts and minors through their guardians.
- 4) Fixed Deposits will not be accepted from unregistered trusts and partnership firms.
- 5) In case of deposit from a shareholder of the Company, the shareholder should be a holder of shares on the date of deposit.
- 6) A deposit in joint names will be treated as a deposit from a shareholder if any one of the joint deposits is a shareholder.

Renewal and Repayment
